How many BVI companies are there?

Total number of BVI active companies is 402,907 (31st Dec. 2018), a 4.6% decrease from 30th September 2018. The European Union announced that it recognises the British Virgin Islands as a cooperative jurisdiction. The Economic Substance Act (bill passed in 20 December 2018) address the EU's specific concerns.
