There are two types of limited liability companies in Andorra: SL (Societat Limitada) and SA (Societat Anonima). Small and medium-sized organizations usually choose the SL form with a minimum declared authorized capital of EUR 3,000, while SA is more suitable for large businesses and requires a minimum capital of EUR 60,000.

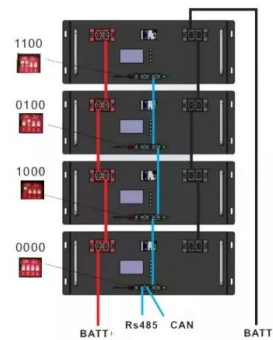

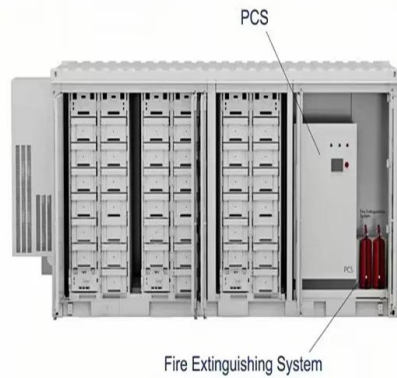

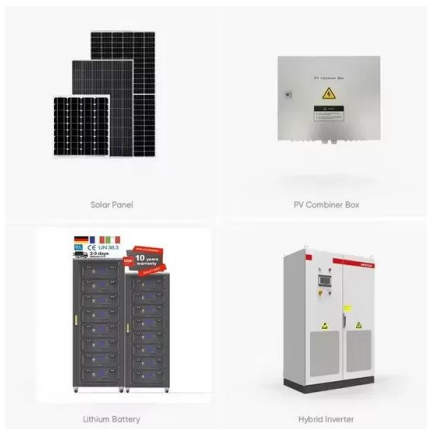
