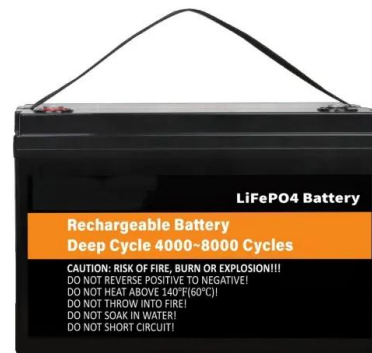


1967 Associated Statehood of St. Kitts, Nevis, and Anguilla
