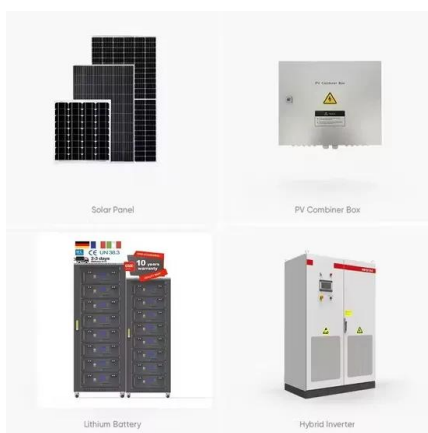


### Premier Oil and Chrysaor agree 'reverse takeover' deal

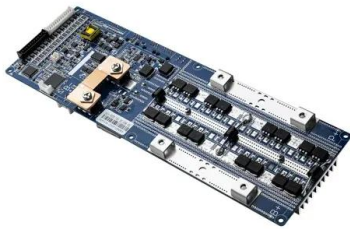

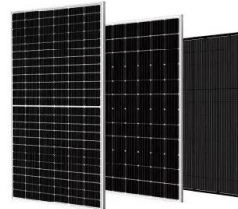

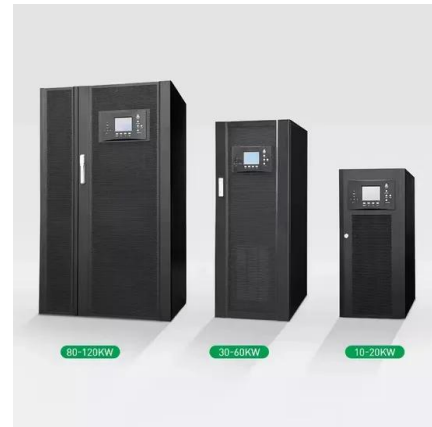
