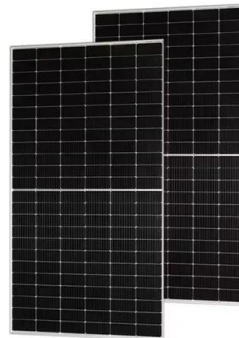

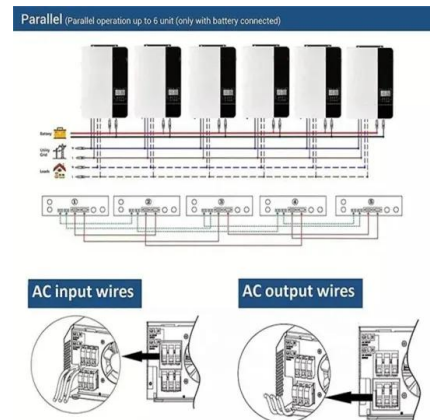

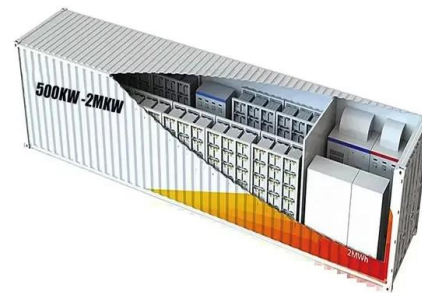


## CTU , Central Transmission Utility of India Limited
