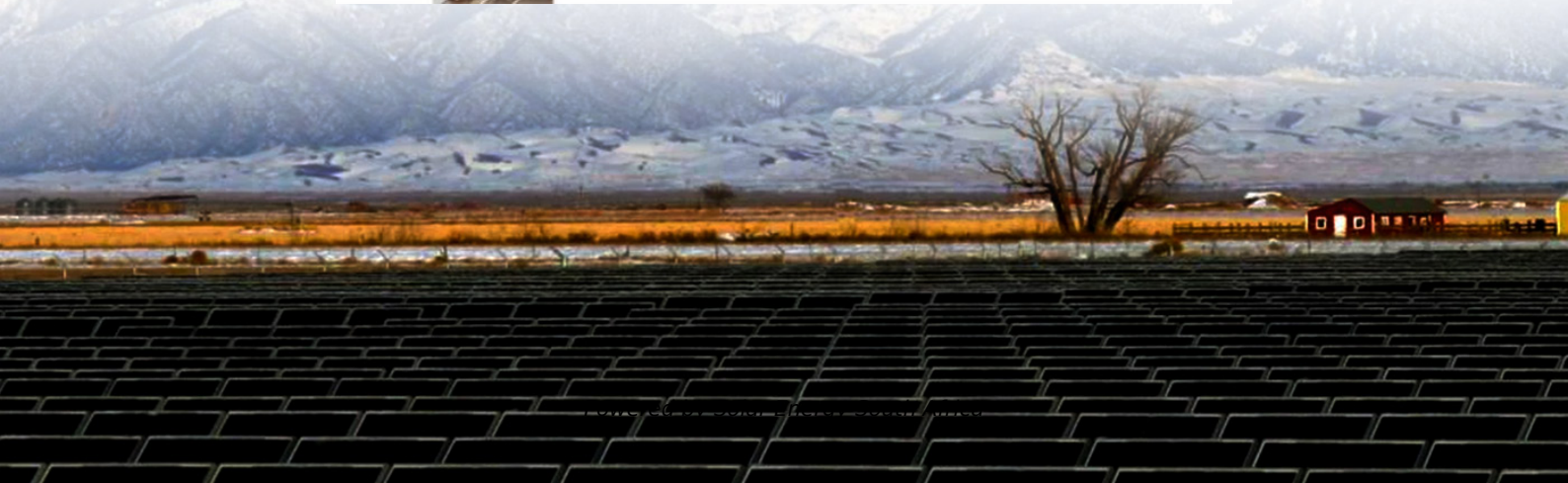

How to register the use information of photovoltaic panels



Overview

You must notify your local DNO if you make any significant change to your connection, such as installing one of the following energy devices: 1. solar photovoltaic (PV) 2. heat pump 3. electric vehicle (EV) charge point 4. battery storage .

What if I don't register my solar panels?

If you're a shared owner or a homeowner and you haven't registered your solar photovoltaic (PV) panels, and they were installed after 14 January 2016, you can apply to your electricity supplier to get the 'Feed-in tariff' (FiT) payments. This is in effect a grant from the Government according to how much electricity your panels are generating.

Why do I need a solar registration?

This includes: Proof of Ownership: A document that proves you are the owner of the property and the solar panel system.
