The demerged Sterlite Power Transmission will now conduct the power capital goods business, comprising cables, conductors and specialised services, and the Sterlite Grid 5 Limited business will house the transmission concessions business, according to the release.

Why did Sterlite power raise funds?

The company aims to use the funds to boost its production capacity, new product development, and expansion in international markets, it said in a press release on Monday. Sterlite Power raised the funds from US-based GEF

Capital Partners and Mumbai-based private equity firm ENAM Holdings.

What happened to Sterlite Power Transmission Ltd?

Sterlite Power Transmission Ltd (SPTL) announced on Thursday that its shareholders have approved the plan to demerge its transmission business. This restructuring will result in the transmission infrastructure being placed under a new entity, Sterlite Grid 5 Ltd, while SPTL will continue to manage the global products and specialized EPC services.

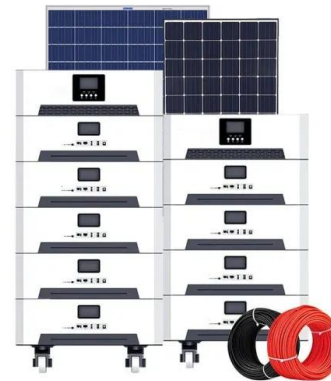

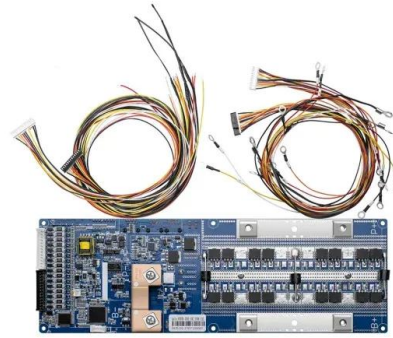

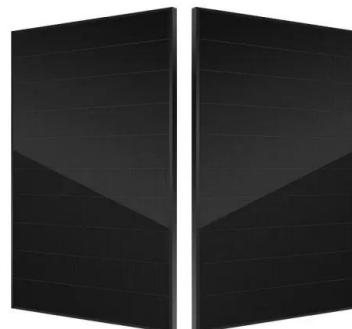
