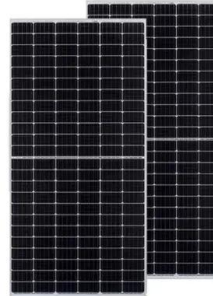


### AB Klaipedos nafta audited Annual information for the year 2021

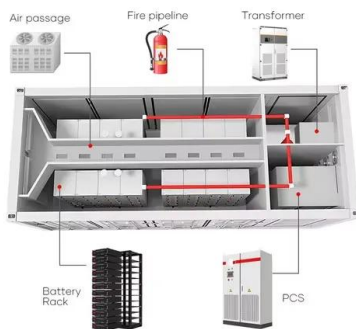

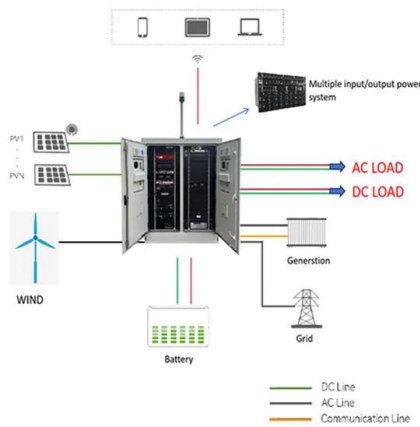
