Where is the largest energy storage project in the UK?

Located in the Selby area in North Yorkshire, the Lakeside Energy Storage Project will be the largest energy storage project in RES' now 420MW portfolio of energy storage in the UK and Ireland once completed. The development has consent for 51 energy storage containers and 42 transformers, with construction expected to start in late 2022.

Will res build a new energy storage project in south west Scotland?

Renewable energy company RES has received planning consent to build a new energy storage project in south west Scotland, following South Ayrshire Council's decision to unanimously approve the scheme, in line with the case.

To that end, the national Central Electricity Authority (CEA) projected a requirement for 82.37GWh of energy storage by the 2026-2027 financial year. This would then scale up to 74GW/411.4GWh of energy storage by the 2031-2032 financial year, including 175.18GWh of pumped hydro energy storage (PHES) and 236.22GWh of battery storage.



## West Lothian Broxburn Energy Storage System, UK

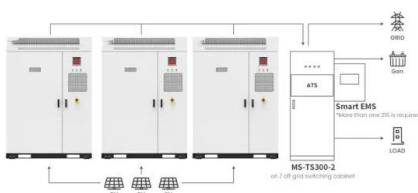
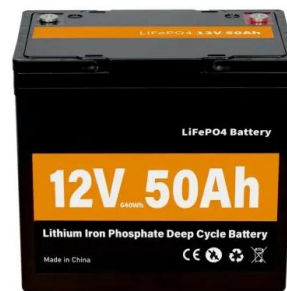
The Renewables Infrastructure Group (TRIG), has

The RES-San Diego Gas & Electric Miramar - Battery Energy Storage System is a 30,000kW energy storage project located in Miramar, San Diego, California, US. The rated storage capacity of the project is 120,000kWh. The electro-chemical battery energy storage project uses lithium-ion as its storage technology. The project was announced in 2017.

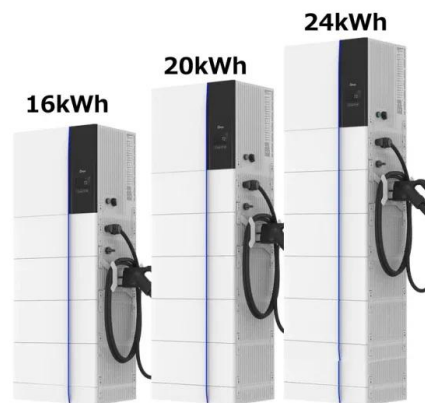
