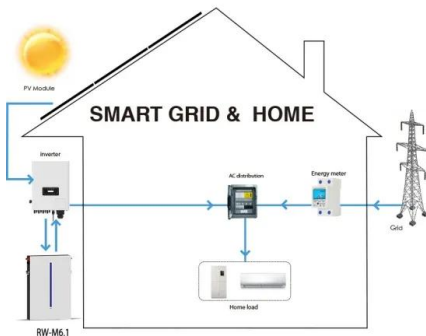

A company shall, not later than April 1 in each year after its incorporation, file its annual return containing the prescribed information made up to 31 December of the previous year. 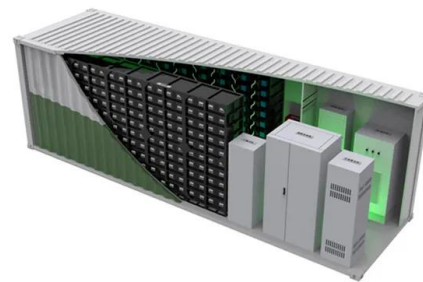
