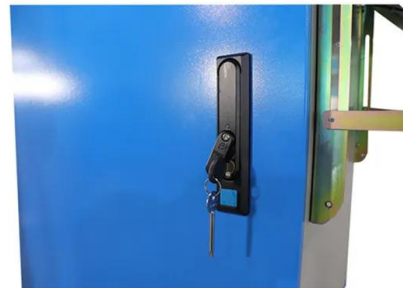

Following the transaction, Super Energy Corporation, through its subsidiary Super Solar Thailand Co, will own around 70 percent in the Loc Ninh 1, 2 and 4 projects, each of 200 MW, and the 150-MW Loc Ninh 3. All of them are scheduled for completion by December 30, 2020, and will get a USD-7.09/kWh feed-in-tariff (FIT) for 20 years, according to a preliminary ...

After its completion, the business' direct and indirect subsidiaries will operate nine solar parks in Vietnam with a combined capacity of 837 MW.
